

Terms and Conditions

1. Agreement between user and www.ficoin.tech

1.1. Welcome to The www.ficoin.tech website (the "Site"). The site is comprised of various web pages operated by FiCoin.

1.2. www.ficoin.tech is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of www.ficoin.tech constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

1.3. Use of this website is limited to parties that are 18 years of age or older.

1.4. The Agreement comes into effect at the moment you register in the Site.

2. Privacy

Your use of www.ficoin.tech is subject to FiCoin's Privacy Policy. Please review our Privacy Policy, which also governs the Site and informs users of our data collection practices.

3. Electronic Communications
